Background

State Health Insurance Assistance Program (SHIP) – The Division of Aging and Adult Services (DAAS) previously received grant award #1N0CMS020186-21-00 from the Centers for Medicare and Medicaid Services (CMS) for the period of April 1, 2013 through March 31, 2014. The goal of this grant is to continue to support the efforts of SHIP and provide public awareness related to community-based events organized by the CMS Regional Office.

SHIP No-Cost Extension
