# Maricopa County Legal Remedies and Victim Resource Guide for Elder Abuse June 2022

# **Terms & Statutory Definitions**

#### **Vulnerable Adult Abuse**

- A.R.S. § 13-3623 Statute that defines the crime of elder abuse. People commit this offense if, under certain circumstances, they cause a vulnerable adult to suffer a physical injury or endangers the person's health or wellbeing. (See Title 13)
- A.R.S. § 46-451(A)(11) "Vulnerable adult" means a 18+ individual who is unable to protect himself from abuse, neglect or exploitation because of a physical or mental impairment. Vulnerable adult includes an incapacitated person as defined in section 14-5101.

#### **Domestic Violence**

 Statutes may apply based on relationship status in the crime.

#### **Emotional Abuse**

 A.R.S. § 13-3623 (F) (3) – Emotional abuse is a pattern of ridiculing, demeaning, making derogatory remarks, verbally harassing, threatening to inflict physical or emotional harm to a vulnerable adult.

# **Financial Exploitation**

■ A.R.S. § 46-451(A)(5) – "Exploitation" means the illegal or improper use of a vulnerable adult or their resources.

## **List of Crimes and Offenses**

Vulnerable Adult Abuse includes physical, sexual, emotional, verbal, domestic or sexual violence, financial exploitation and meets the definition of a vulnerable adult. Later in Life Abuse refers to older adults that are 50+ years old. It is important to realize that age alone does not qualify an individual as a vulnerable adult. An alert, functioning 80-year-old may not be a vulnerable adult. When investigating, it is critical to look for changes in the person's overall behaviors. Look for: communication style, economic conditions, emotional health, physical limitations, personal appearance and condition of the surroundings.

To determine victim's mental state, refer to the MAG's Vulnerable Adult Protocol for a list of physical or mental functioning, neglect, abuse, or financial exploitation status indicators. Dementia is a general term for loss of memory and mental abilities severe enough to interfere with daily life. Learn more at alz.org/firstresponders.

# **Investigation Tips**

## **Financial Exploitation**

- Obtain all information on victim, including PII, contact, NOK, Medical (doctor(s), prescriptions, diagnosis)
- Obtain all banking information (Bank Names, Account Number(s))
- If guardianship is present, document dates when established
- Impound copies of ALL evidence (Bank records, court orders, medical records, if available)

#### In-Home Calls

- Document what makes the person a VA
- Interview all present in home, including victim, if possible
- Photograph injuries and the home environment, including med supplies, food, etc.
- Collect relevant evidence
- Follow-up at hospital if applicable
- Report to APS

# **Group/Facility Calls**

- Document what makes the person a VA
- Interview any staff with knowledge of incident and collect their identifying and contact info
- Collect victim's face sheet, care notes and incident report(s)
- Check security cameras, view if possible, then document
- Follow-up at hospital if applicable
- Report to APS

# **Patrol Response**

- Must be able to prove impairment/vulnerability
- Prove or establish the suspect is in a position of
- Trust & Confidence
- Provide mandated victims' rights information pursuant to A.R.S.
   § 13-4405 information provided to victim by law enforcement agencies
