Older Americans Act Title III and VII for SFY-2013

This ALERT applies to the Pinal-Gila Council for Senior Citizens.

This ALERT is being provided to non-participating regions as information only.

Funding Allocation – Family Caregiver Support Program (Title III-E)

To support the development of a statewide respite care network through collaboration between the Area Agencies on Aging (AAAs), the Arizona Caregiver Coalition (ACC), and the Division of Aging and Adult Services, an allocation of \$15,000 in Title III-E funding is being made to Pinal/Gila Council for Senior Citizens (PGCSC) on behalf of the Arizona Association of Area Agencies on Aging (AZ4A). This funding will be used to coordinate activities and community education events between AZ4A and the ACC. These activities and events being planned by the ACC will target service providers, community partners, and other stakeholders that support caregivers to participate in a Statewide Summit on Respite Care and other meetings related to the development of respite vouchers and an online respite registry. The funds will support participation of a representative of the AZ4A in the planning of these events and activities and will provide support for stakeholders to participate. Conference calls will be scheduled in September 2012 to discuss further details and to allow input. The AZ4A representative will be responsible to inform the AAAs of the specific dates and times of the calls, provide input or feedback on behalf of the AAAs, and ensure that the AAAs are aware of the discussion topics and outcomes of these discussions.

This ALERT is being provided to non-participating regions as information only.

Per ALERT SFY-13-5A issued on May 31, 2012, Program Year (PY) 2012/State Fiscal Year (SFY) 2013 Senior Community Service Employment Program (SCSEP) performance goals had not yet been determined and were to be forwarded to sub-grantees once they were finalized.

Attachment A to this ALERT provides SCSEP final performance goals for PY 2012/SFY 2013. Each sub-grantee will be held accountable to meet or exceed these goals as they relate to their respective service delivery areas. The annual calculation of these goals is based on the Quarter 3 grantee Quarterly Progress Reports (QPR) which is a compilation of sub-grantee performance.

QPRs are generated each weekend by U.S. Department of Labor/Employment and Training Administration (USDOL/ETA). Sub-grantees are directed to verify and correct all rejected records no later than the week following the generation of these reports. Outstanding rejected records have a negative impact on the calculation of these goals.

The number of authorized positions is modified to account for higher state minimum wages. Authorized positions are reported in Section A4 of the Quarterly Progress Report (QPR). SCSEP Performance and Results QPR uses modified positions rather than authorized positions for calculating vacancies in Section B of the QPR and service level and the community service measure in Section E.

This ALERT applies to the Area Agency on Aging, Region One, Inc., the Pima Council on Aging, Northern Arizona Council of Governments Area Agency on Aging, Western Arizona Council of Governments Area Agency on Aging, Pinal-Gila Council for Senior Citizens, and SouthEastern Arizona Governments Organization Area Agency on Aging.

Care Partners Reaching Out Grant (CarePRO) – The Division of Aging and Adult Services (DAAS) previously received grant awards from the Administration on Aging (AoA) for the Alzheimer's Disease Supportive Services Program (ADSSP). The initial grant (#90AE0330-01) covered the period from September 30, 2008 – September 29, 2011, and the remaining grant (#90AE0335-01) covered from September 30, 2009 – September 29, 2012. During recent meetings with AoA, a no-cost extension was negotiated for this remaining grant, extending the grant project period until June, 30, 2013.

All previously allocated funds are now available for use in the CarePRO project until June 30, 2013. The new allocations below are based on analysis of current usage, and funding levels will be re-evaluated in January 2013 to allow possible re-allocation of unused funds.

All CarePRO funds must be expended by June 30, 2013. Final billings for services provided through CarePRO funding must be submitted by August 16, 2013. The Area Agencies on Aging (AAAs) shall provide Non-Fed Match (cash or in-kind) as indicated in the allocation tables above. Failure to provide the match shall result in a proportionate reduction of the contract funding. Required match must be identified in each submitted billing in order for payments to be processed.

This ALERT applies to the Area Agency on Aging, Region One, Inc., the Pima Council on Aging, Northern Arizona Council of Governments Area Agency on Aging, and the Pinal-Gila Council for Senior Citizens.

This ALERT is being provided to non-participating regions as information only.

In 2009, the Division of Aging and Adult Services (DAAS) received a grant award from the Administration on Aging (AoA) for **ADRC Care Transitions** with funding allocations made for SFY 2010, 2011, and 2012. In 2010, the Division of Aging and Adult Services (DAAS) received a grant award from the Administration on Aging (AoA) for the **ADRC Options Counseling Program** with funding allocations made for SFY 2011 and 2012. Both grant funding periods are scheduled to end September 29, 2012.

The Division of Aging and Adult Services has requested a nine month no-cost extension from the Administration for Community Living (ACL) for both grants. If granted, all funds available for ADRC Care Transitions (AOC, AAC, ATC) and ADRC Options Counseling (AOP) must be expended by June 30, 2013.

Each participating Area Agency on Aging will be contacted by DAAS to discuss the status of ongoing activities as well as any proposed changes. The ACL has approved changes in the requirements and budgets, allowing pilot sites to enhance collaboration between Options Counseling and Care Transitions as well as other ADRC functions.

The Options Counseling summary report will be prepared by September 29, 2012. Other reporting requirements remain unchanged for both Options Counseling and Care Transitions. This includes the SART in October 2012 and April 2013 and the Options Counseling data tracking and satisfaction survey results. Participating Area Agencies are requested to participate in regular conference calls to discuss activities and outcomes.

Technical Assistance for SFY-2013

Technical Assistance ALERTS are generated periodically to update contractual and/or programmatic requirements and/or clarifications.

The purpose of this ALERT is to notify Area Agencies on Aging (AAAs) of an allowable exception to the fingerprint clearance card level one requirement.

As a practice, the Department of Economic Security has allowed the following:

- 1. If an employee has a regular clearance card that was issued prior to June 29, 2009, and has been an employee of the SAME provider/agency the regular card can be accepted.
- 2. If the employee was hired or transferred to the provider/agency after June 29, 2009, they are required to have a level one fingerprint clearance card.

A.R.S. §41-1758.07 section Q, states, "Unless a cardholder commits an offense listed in subsection B or C of this section after June 29, 2009, a fingerprint clearance card issued pursuant to section 41-1758.03 before June 29, 2009 and its renewals are valid for all requirements for a level I fingerprint clearance card except those relating to the requirements of section 8-105 or 8-509......."

After seeking clarification on the interpretation of Section Q, the Division of Aging and Adult Services (DAAS) was informed that individuals with regular clearance cards should be grandfathered in until the regular clearance cards expire in 2015. This is an allowable exception to the DAAS Special Terms and Conditions addressing the requirement for a level one clearance card. AAA Directors are encouraged to seek legal counsel on the application of this exception for their local areas.

DAAS contract monitoring tools will be amended accordingly.

Technical Assistance for SFY-2013

Technical Assistance ALERTS are generated periodically to update contractual and/or programmatic requirements and/or clarifications.

The purpose of this ALERT is to notify Area Agencies on Aging (AAAs) of changes in the Central Registry Background Check forms, the Arizona Department of Economic Security (ADES) Central Registry Background Check process, and the Division of Aging and Adult Services (DAAS) Special Terms and Conditions.

This ALERT addresses the required modification to two (2) contract Special Terms and Conditions:

(1) <u>DAAS Special Terms and Conditions, Background Checks for Employment through the Central Registry for non-profit agencies; Terms and Conditions, Background Checks for Employment through the Central Registry for public and Tribal entities</u>

In late July 2012, ADES contractors and potential contractors were advised through a communication initiated through the State's automated procurement system, ProcureAZ, that:

- 1) The Arizona Department of Economic Security is required by law to maintain a central registry of substantiated reports of child abuse and neglect.
- 2) Senate Bill 1136 was passed during the last legislative session, and became effective August 2, 2012. It changed the requirements for Contractors (their employees and prospective employees) and subcontractors (their employees and prospective employees) regarding a Central Registry Background Check, and required ADES to notify individuals with disqualifying acts that they may apply to the Board of Fingerprinting for a Central Registry exception.

As a result of the bill, the Department modified the Request for Search of Central Registry for Background Check form (See Attachment A) to add space to indicate each individual's address. There were also additions to the cover page to help facilitate ADES processing.

Please note, it is <u>important</u> that:

- All information on the cover page be completed,
- Utilization of this revised form begin as soon as possible, and
- Subcontractors also begin using the form as soon as possible.

The Direct Service Position form was also modified by the Department. This certification is required to be completed and maintained for all new hires. (See Attachment B)

The DAAS Special Term and Condition currently in contracts will be replaced with the following:

- **5.0** Background Checks for Employment through the Central Registry. If providing direct service to children or vulnerable adults, the following shall apply:
- 5.1 The provisions of A.R.S. § 8-804 (as may be amended) are hereby incorporated in its entirety as provisions of this Contract.
- 5.2 The Department will conduct Central Registry Background Checks and will use the information contained in the Central Registry as a factor to determine qualifications for positions that provide direct services to children or vulnerable adults for:
 - 1. Any person who applies for a contract with this State and that person's employees;

- 2. All employees of a contractor;
- 3. A subcontractor of a contractor and the subcontractor's employees; and
- 4. Prospective employees of the contractor or subcontractor at the request of the prospective employer.
- 5.3 Volunteers who provide direct services to children or vulnerable adults shall have a Central Registry Background Check which is to be used as a factor to determine qualifications for volunteer positions.
- 5.4 Effective August 2, 2012:
 - 1. A person who is disqualified because of a Central Registry Background Check may apply to the Board of Fingerprinting for a Central Registry exception pursuant to A.R.S. § 41-619.57. A person who is granted a Central Registry exception pursuant to A.R.S. § 41-619.57 is not entitled to a contract, employment, licensure, certification or other benefit because the person has been granted a Central Registry exception.
 - 2. Before being employed or volunteering in a position that provides direct services to children or vulnerable adults, persons shall certify on forms that are provided by the Department whether an allegation of abuse or neglect was made against them and was substantiated. The completed forms are to be maintained as confidential.
- 5.5 The person shall not provide direct services to ADES clients until the results of the Central Registry Background Check are complete and the results indicate that the person has no disqualifying acts that would prohibit him/her from providing services to ADES clients. If the Central Registry Background Check specifies any disqualifying act and the person does not have a Central Registry exception, the person shall be prohibited from providing direct services to ADES clients.
- 5.6 The Contractor shall maintain the Central Registry Background Check results and any related forms or documents in a confidential file for five (5) years after termination of the Contract.
- (2) <u>ADES Special Terms and Conditions, Confidentiality for non-profit agencies; Terms and Conditions, Confidentiality for public and Tribal entities</u>

In Spring, 2011 State legislation established the Address Confidentiality Program (ACP). Information was subsequently provided to ADES contractors and potential contractors through a communication initiated through ProcureAZ and through emails initiated by DAAS staff.

As a result of the legislation, the following will be added to the Confidentiality section:

The Contractor shall comply with the requirements of Arizona Address Confidentiality Program, A.R.S. §41-161 et. seq. The Arizona Department of Economic Security will advise the Contractor as to applicable policies and procedures the Arizona Department of Economic Security has adopted for such compliance.

The two above mentioned changes to contract terms and conditions will be amended into contracts. If you have any questions, please contact your Contract Specialist.
