Disease Prevention Health Promotion Program – The Department of Economic Security, Division of Aging and Adult Services (DAAS), through the Arizona Department of Health Services (ADHS), received a grant award for Chronic Disease Self Management Education (CDSME) from the Administration for Community Living (ACL). The overall amount of the award was \$151,234. The grant period is **October 1, 2012 – August 31, 2015**. The goal of this grant is to increase the number of older and/or disabled adults in Arizona with chronic conditions who complete the Healthy Living, Chronic Disease Self-Management Program (CDSMP) and Diabetes Self-Management Program (DSMP) as well as expand integrated and sustainable services systems within Arizona.

This ALERT includes the following topic areas: 1) CDSME allocations to Area Agencies on Aging (AAA); 2) CDSME service codes for the Social Services Report and 3) Updated 38.0 Scope of Work (SOW) Health Education – Disease Prevention and Health Promotion (Attachment A).

CDSME Allocations:

There is not a federal match required for this allocation.

This grant is designed to expand the Healthy Living (Chronic Disease Self-Management Program) and Diabetes Self-Management Program (DSMP) in Spanish and English throughout Arizona.

The allocations included in the table below are intended to assist AAAs to participate in a collaborative process in support of the CDSME grant. These activities include increasing the delivery of Healthy Living, CDSMP and DSMP to populations in Arizona who are Spanish speaking, rural and minority populations by expanding integrated and sustainable services systems.

38.0 HEALTH EDUCATION – DISEASE PREVENTION AND HEALTH PROMOTION

38.1 Purpose Statement

38.1.1 The purpose is to provide information and services that help reduce the impact of disease, chronic conditions, and minimize health-related risk factors associated with aging.

38.2 Service Description

- 38.2.1 Taxonomy Definition A service that provides individual or group instruction to maintain or improve physical well-being.
- 38.2.2 Health promotion and disease prevention programs are designed to maintain or improve the emotional and physical well-being of older adults.
- 38.2.3 Evidence-based health promotion and disease prevention programs that relate to prevention and mitigation of the effects of chronic disease for participants and eligible individuals in the community are provided.
- 38.2.4 Programs provide planned activities to identify, prevent, or decrease risk factors for specific conditions, diseases, and injuries.
- 38.2.5 Programs provide a variety of health promotion activities on a weekly basis at senior centers that may include; health risk assessments, blood pressure checks, physical fitness, medication management, health screenings, and disease specific education.
- 38.2.6 Programs increase participants' control of factors associated with optimal psychosocial and physical health through education.
- Programs provide nutrition education to promote health and help to prevent disease by improving the diets of older adults and assisting them achieve or maintain optimal nutritional status.
- 38.2.8 Programs provide information and access to community resources.
- 38.2.9 Related to outreach including information and referral, the service:
 - 1. Provides the individuals with current information on opportunities and services available to the individuals within their communities.
 - 2. Links the individuals to the opportunities and services that are available.
 - 3. To the maximum extent practicable, ensures that the individuals receive the services needed by the individuals, and individuals are aware of the opportunities available to the individuals, by establishing adequate follow-up procedures as applicable.
 - 4. Provide outreach materials related to evidence-based disease prevention health promotion programs and information as available.

38.2.10 Related to Chronic Disease Self-Management Education (CDSME) grant:

- 1. Increase the number of older and/or disabled adults in Arizona with chronic conditions who complete the Healthy Living (Stanford Chronic Disease Self-Management Program) in English and Spanish and/or the Diabetes Self-Management Program (DSMP) in English and Spanish with a purpose of maintaining or improving individual health status.
- 2. Strengthen and expand integrated and sustainable service systems within Arizona to provide Healthy Living (Stanford Chronic Disease Self-Management Program) in English and Spanish and/or the Diabetes Self-Management Program (DSMP) in English and Spanish.
- 38.2.11 Eligibility Requirements The Contractor shall provide services to individuals that meet the eligibility requirements described in Chapter 3300 of the DAAS Policy and Procedure Manual, as may be amended.

38.3 Service Requirements – The Contractor shall:

- 38.3.1 Title IIID section 361 of the Older Americans Act for Disease Prevention and Health Promotion shall only be used for programs and activities which have been demonstrated through rigorous evaluation to be evidence-based and effective.
- Where applicable, partner with community health centers, mental health centers, state and local government agencies, centers for independent living, public health departments, state and local non-profit organizations, educational and/or health care institutions, community organizations, or other identified entities to provide one or more of the services listed below:
 - 1. Health risk assessments.
 - 2. Routine health screenings, which may include hypertension, glaucoma, cholesterol, cancer, vision, hearing, diabetes, bone density, and nutrition screening.
 - 3. Nutritional counseling and educational services for individuals and their primary caregivers.

- 4. Evidence-based health promotion programs, including programs related to the prevention and mitigation of the effects of chronic disease (including osteoporosis, hypertension, obesity, diabetes, and cardiovascular disease), alcohol and substance abuse reduction, smoking cessation, weight loss and control, stress management, depression, falls prevention, physical activity and improved nutrition.
- 5. Programs regarding physical fitness, group exercise and music, art, and dance-movement therapy, including programs for multigenerational participation that are provided by an institution of higher education, a local educational agency, or a community-based organization.
- Home injury control services, including screening of high risk home environments and provision of educational programs on injury prevention (including fall and fracture prevention) in the home environment.
- 7. Screening for the prevention of depression, coordination of community mental health services, provision of educational activities, and referral to psychiatric and psychological services.
- 8. Educational programs on the availability, benefits, and appropriate use of prevention health services covered under Title XVIII of the Social Security Act (42 USC 1395 et seq.), as may be amended.
- Information concerning diagnosis, prevention, treatment, and rehabilitation concerning agerelated diseases and chronic disabling conditions, including osteoporosis, cardiovascular diseases, diabetes, and Alzheimer's disease and related disorders with neurological and brain dysfunction.
- 10. Gerontological counseling.
 - 11. Counseling regarding social services and follow-up health services.
- 38.3.3 Provide disease prevention health promotion information to individuals.
 - 1. Identify needs and provide simple and/or complex information in response to written, telephone, walk-in or electronic requests from individuals or community agencies.
 - 2. Identify problems and/or barriers which prevent the receipt of needed services and intercede on behalf of the individual.
 - 3. Disseminate information to the public about Information and Referral Services.
 - 4. Document every referral provided to each individual for each identified need.
- 38.3.4 Refer individuals to human services and community resources, as appropriate.
 - 1. Identify needs and provide referral information in response to written, telephone, or walkin requests from individuals or community agencies.
 - 2. Follow-up with individuals as appropriate
- 38.3.5 Provide the following Disease Prevention and Health Promotion activities if the AAA is a designated Chronic Disease Self-Management Education (CDSME) recipient:
 - 1. Work in partnership with the Arizona Living Well Institute to carry out CDSME grant work plan deliverables.
 - Increase the number of Arizonans who enroll in the Healthy Living (Chronic Disease Self-Management Program) in English and Spanish.
 - 3. Increase the number of host organizations that provide Healthy Living (Chronic Disease Self-Management Program) and the Diabetes Self-Management Program (DSMP) in English and Spanish.
 - 4. Systematically embed CDSMP and CDSME into service systems to provide CDSMP and DSMP workshops.
- 38.4 Licensure/Certification Requirements The Contractor shall:
- 38.4.1 Ensure certification and licensure standards are met when providing an evidenced-based program for which licensing or certification requirements exist.
- 38.4.2 Ensure that educators/presenters providing health promotion activities meet appropriate certification/licensure standards.
- 38.5 Performance Measure
- 38.5.1 Number of evidence-based program offered annually.
- 38.5.2 Number of participants completing evidence-based programs.
- 38.5.3 Number of screening events held annually.
- 38.6 Reporting Unit
- 38.6.1 One unit of service equals one activity.

The Aging and Disability Resource Consortium (ADRC) utilizes funds from two grants: The 2009 ADRC – Care Transitions grant (code: AOC) and the 2010 ADRC - Options Counseling grant (code: AOP). Agencies are encouraged to plan activities holistically in order to strengthen the ADRC, linking Options Counseling, Care Transitions, training and outreach wherever possible.

The Scope of Work is Information and Referral.

Deadlines for use of funds:

Both fund sources may be used for ADRC-related activities, including Care Transitions and Options Counseling, but they have different end dates.

- AOP funds must be used by June 30, 2013
- AOC funds must be used by September 29, 2013

Re-Allocation of funds:

The following change in allocations is made to ensure that all participating AAAs have funds available until September 29, 2013:

• Region One, Inc. (including ABIL): \$24,460 of AOP funds will be replaced by \$24,460 of AOC funds. Total funding levels will not change.

Lifespan Respite Program (LRP) – The Division of Aging and Adult Services (DAAS) previously received grant award # 90LR0004-01 from the Administration for Community Living for the LRP for the period of September 30, 2009 – September 29, 2012. The goal of this grant was to continue to develop the Arizona LRP and improve public awareness related to the value and importance of respite care for all caregivers throughout Arizona, assuring culturally appropriate respite services are accessible to diverse populations of caregivers. A new 18 month grant (# 90Ll0003-01) was awarded to Arizona in September of 2012 to sustain and integrate the Lifespan Respite Program.

LRP Allocation to continue service delivery in Region One:

Area Agency on Aging (AAA), Region One, Inc. was the only AAA that was funded in response to the LRP funding opportunity tied to the initial LRP grant that was included in ALERT SFY-10-11G, dated February 26, 2010. This ALERT includes additional funding to AAA, Region One Inc. from the new grant to continue to serve the LRP clients they identified in the initial grant project. This continuation funding is included in the AAA, Region One Inc. allocation below, and requires Non-Fed Match as indicated.

Allocated funds are available for use in the LRP grant project until January 31, 2014. AAA, Region One, Inc. should expect to receive a call from the DAAS staff in April/May 2013 to review the status of allocated funds, and to work with the AAA to estimate the amount to be carried over into SFY 2014 for use until the grant ends.
